## Pledge Summary

Pacific Grove is a community of 15,000 located on the Pacific coast in Monterey County, California. We are an overwintering site for Monarch butterflies and have enormous community support for the iconic butterfly, which is incorporated into our city logo, and is part of the identity of the city. Each year we hold a Butterfly Parade to welcome the butterflies to town; with school children of all ages participating, and enthusiastic spectator support, this event a community-wide celebration. We are sustaining our Monarch Sanctuary and will be continuing and initiating new efforts to encourage residents to plant nectar gardens and maintain safe landscapes for the Monarchs.

## Action Items Committed for 2023

### Communications and Convening

- Launch or maintain a public communication effort to encourage residents to plant monarch gardens at their homes or in their neighborhoods. - Launch, expand, or continue an effort to change municipal planting ordinances and practices to include more native milkweed and native nectar producing plants at city properties.
- Integrate monarch butterfly conservation into the city’s Park Master Plan, Sustainability Plan, Climate Resiliency Plan or other city plans.
- Reduce or eliminate the use of herbicides, pesticides, or other chemicals that are harmful to monarchs and pollinators and urban wildlife.
