Since 2016, Branson Missouri's Mayor, citizens, residents and businesses have embraced the Mayors for Monarchs initiatives, installing over 1,000 milkweed stems and multiple gardens with signage. Our "crowd sourced" pollinator garden map allows people who have planted both milkweed and nectar plants to place a "Monarch" icon over their location. Thank you to the many local partners and leaders who contributed to our success.
