Pledge Summary

Granbury Texas is a city in north Texas, located 35 miles southwest of the Dallas/Fort Worth Metroplex, with a population of 12, 000. Granbury is located squarely on the monarch butterfly migration route. Mayor Jarratt is keenly interested in energizing the community to roll out the 'Welcome Mat' for migrating Monarch Butterflies through educational programs, an established demonstration garden maintained by Lake Granbury Master Gardeners and a year-round effort to plant milkweed, culminating in an annual celebration during the migration - Romancing the Monarch Butterfly Festival the first Saturday in October.

Action Items Committed for 2023

Communications and Convening

- Issue a proclamation to raise awareness about the decline of the monarch butterfly and the species' need for habitat. This proclamation must incorporate a focus on monarch conservation.
- Launch or maintain a public communication effort to encourage residents to plant monarch gardens at their homes or in their neighborhoods. - Engage with community garden groups and urge them to plant native milkweeds and nectar-producing plants.

- Integrate monarch butterfly conservation into the city’s Park Master Plan, Sustainability Plan, Climate Resiliency Plan or other city plans.
