Pledge Summary

Granbury Texas is a city in north Texas, located 35 miles southwest of the Dallas/Fort Worth Metroplex, with a population of 12, 000. Granbury is located squarely on the monarch butterfly migration route. Mayor Jarratt is keenly interested in energizing the community to roll out the 'Welcome Mat' for migrating Monarch Butterflies through educational programs, an established demonstration garden maintained by Lake Granbury Master Gardeners, and a year-round effort to plant milkweed, culminating in an annual celebration during the migration - Romancing the Monarch Butterfly Festival the first Saturday in October.

Action Items Committed for 2025

Communications and Convening

- Issue a proclamation to raise awareness about the decline of the monarch butterfly and the species' need for habitat. This proclamation must incorporate a focus on monarch conservation.
- Launch or maintain a public communication effort to encourage residents to plant monarch gardens at their homes or in their neighborhoods. (If you have community members who speak a language other than English, we encourage you to also communicate in that language; Champion Pledges must communicate in that language.)
- Engage with community garden groups and urge them to plant native milkweeds and nectar-producing plants.
- Engage with gardening leaders and partners (e.g., Master Naturalists, Master Gardeners, Nature Centers, Native Plant Society Chapters , other long-standing and influential community leaders) to support monarch butterfly conservation.

- Create a community art project to enhance and promote monarch and pollinator conservation as well as cultural awareness and recognition.

Systems Change

- Change weed or mowing ordinances to allow for native prairie and plant habitats.
- Increase the percentage of native plants, shrubs and trees that must be used in city landscaping ordinances and encourage use of milkweed, where appropriate.
- Reduce or eliminate the use of herbicides, pesticides, or other chemicals that are harmful to monarchs and pollinators and urban wildlife.
