Pledge Summary

The City of Shavano Park is located on the edge of the Texas Hill Country and offers a unique blend of rural small town character with urban conveniences. The City's motto is "City living with Country Charm," a phrase the City lives up to by being a nature and wildlife habitat. The City has committed to saving the Monarch Butterfly by planting the Milkweed plant at City Hall, community garden and municipal buildings. The City also informs the Residents of their ability to contribute by proclaiming April as Monarch Pledge Month in conjunction with the City's annual Arbor Day Celebration.

Action Items Committed for 2021

Communications and Convening

- Issue a proclamation to raise awareness about the decline of the monarch butterfly and the species' need for habitat. This proclamation must incorporate a focus on monarch conservation.
- Engage with community garden groups and urge them to plant native milkweeds and nectar-producing plants.

- Host or support a native seed or plant sale, giveaway or swap.

- Earn or maintain recognition for being a wildlife-friendly city by participating in other wildlife and habitat conservation efforts (i.e., National Wildlife Federation's Community Wildlife Habitat program).
- Add or maintain native milkweed and nectar-producing plants in gardens in the community.
