## Pledge Summary

Iowa City is committed to creating an environment that will allow monarchs to thrive and rehabilitate during the summer months, and over the last few years has taken steps to help support the monarch butterfly. We hold a Monarch Festival every year, in varying formats, and have seen attendance grow each year! We do crafts, share videos, and engage participants in educational initiatives. ### Communications and Convening
