## Pledge Summary

Bemidji is a city in northern Minnesota with a population of approximately 15,000. Bemidji is the First City on the Mississippi and home to Lake Bemidji, and 22 parks, native landscapes and community gardens. Mayor Prince of Bemidji has committed to saving the monarch butterfly and other pollinators with the signing of the Mayor's Monarch Pledge. We are excited to continue to engage our community in creating more pollinator habitat and providing education on pollinators throughout the city.
