The Village of Hawthorn Woods, Illinois, located just 35 miles north of the City of Chicago with approximately 9,062 residents, is an upscale, friendly “rural by design” community. As a certified Bee City USA and Tree City USA affiliate, an Audubon International Sustainable Community, and an International Dark Sky Community, the Village is fiercely committed to protecting our natural resources, boasting twenty-four park sites and two pollinator habitats – Brierwoods Preserve and Meadowlark Park and Arboretum. Mayor Dominick DiMaggio of the Village of Hawthorn Woods, Illinois, has committed to saving the Monarch butterfly and other pollinators with the signing of the Mayors’ Monarch Pledge and looks forward to expanding pollinator environments throughout the community.

Action Items Committed for 2022

Communications and Convening

- Issue a proclamation to raise awareness about the decline of the monarch butterfly and the species’ need for habitat. This proclamation must incorporate a focus on monarch conservation.

Program and Demonstration Gardens

- Host or support a native seed or plant sale, giveaway or swap.

Pollinator pockets were created within 22 of our neighborhood island cul-de-sacs throughout the Village of Hawthorn Woods, totaling 1.5 acres. The Phoebe Snetsinger Memorial Garden was also implemented this year in our Community Park, which is a 1/2-acre pollinator garden.

As a proclaimed waystation for the Monarch Butterfly, the Village of Hawthorn Woods remains steadfast in our commitment to sustainable environmental stewardship.

The Village of Hawthorn Woods is proud to partner with the Illinois Monarch Project to educate, inform, and advocate for the further establishment of pollinator habitats in residential communities. As a new resource, the Village would welcome funding

opportunities through the Illinois Department of Natural Resources and the Illinois Department of Agriculture. A useful resource would be a central database of all non-profit organizations involved in Monarch preservation activities throughout the Chicagoland area.

What else should we know about your monarch butterfly conservation efforts over the last year?

This year, the Village of Hawthorn Woods completed the final Phase 2 of our Pollinator Pocket Program with the implementation of "pollinator pockets" within 22 of our 44 neighborhood cul-de-sac islands. Phase 1 was completed last year with the implementation of pollinator pockets within 22 of our neighborhood cul-de-sac islands.

A total of 1.5 acres of buckthorn was removed at our yet to be dedicated Indian Creek Preserve and a total of 5.5 acres of teasel was removed at our Meadowlark Park and Arboretum and our Community Park.

Please describe the extent of revisions or maintenance to invasive species removal programs, as well as the practices or techniques used to remove the invasive plants.

All invasive buckthorn and teasel were removed by hand, including all root systems. This extensive invasive removal was conducted by our Parks staff and numerous volunteer groups, such as: Friends of Indian Creek Wetlands; Greenest Region Corps; Hawthorn Woods in Bloom Committee; Stevenson High School Green Team.
