## Pledge Summary

The City of Riverside has a proud history of promoting healthy living spaces including native plants and fostering areas of growth for natural habitats for insects and wild life. With a population of roughly 326,000, the city is home to the historic Mission Inn Hotel & Spa, the beautiful Santa Ana River and UCR Botanical Gardens. Mayor Lock Dawson has committed to saving the monarch butterfly and other pollinators with their signing of the Mayors' Monarch Pledge and looks forward to engaging residents in building more pollinator habitat throughout the city. This year, we plan on planting a community garden here at City Hall for native, nectar producing plants to increase the population of monarchs in our city.

## Action Items Committed for 2022

### Communications and Convening

- Issue a proclamation to raise awareness about the decline of the monarch butterfly and the species' need for habitat. This proclamation must incorporate a focus on monarch conservation.
- Launch or maintain a public communication effort to encourage residents to plant monarch gardens at their homes or in their neighborhoods.
