## Pledge Summary

The City of Houston is the largest city in Texas and fourth most populous city in the United States with over 2.3 million residents. Houston is situated in the convergence of the piney woods and gulf coast prairie, with numerous major bayous and waterways leading to Galveston Bay. Mayor John Whitmire is committing to protect the monarch butterfly and other pollinators through actions taken by the City of Houston staff to propagate and plant milkweed plants, establish and restore native habitat, and engage the community in monarch conservation.

## Action Items Committed for 2026

### Communications and Convening

- Engage with city parks and recreation, public works, sustainability, and other relevant staff to identify opportunities to revise and maintain mowing programs and milkweed / native nectar plant planting programs.
- Engage with gardening leaders and partners (e.g., Master Naturalists, Master Gardeners, Nature Centers, Native Plant Society Chapters , other long-standing and influential community leaders) to support monarch butterfly conservation.

### Program and Demonstration Gardens

- Facilitate or support a milkweed seed collection and propagation effort.
- Earn or maintain recognition for being a wildlife-friendly city by participating in other wildlife and habitat conservation efforts (i.e., National Wildlife Federation's Community Wildlife Habitat program).
- Add or maintain native milkweed and nectar-producing plants in gardens in the community.
- Launch, expand, or continue an invasive species removal program that will support the re-establishment of native habitat for monarch butterflies and other pollinators.

### Systems Change

- Change weed or mowing ordinances to allow for native prairie and plant habitats.
- Increase the percentage of native plants, shrubs and trees that must be used in city landscaping ordinances and encourage use of milkweed, where appropriate.
