Our community has demonstrated growing interest in pollinator conservation through park improvements, native and adaptive landscaping, and public education efforts that encourage environmental responsibility. By expanding the use of native milkweed and nectar-producing plants, reducing pesticide use where feasible, and integrating pollinator-friendly practices into park maintenance and development, Richland Hills aims to create welcoming habitat for monarchs throughout their migratory journey. Through the Mayor's Monarch Pledge, Richland Hills looks forward to strengthening partnerships, engaging residents, and promoting awareness of simple actions individuals can take to support monarch butterflies and other pollinators. Together, we are committed to creating a healthier, more sustainable community for current and future generations.

Action Items Committed for 2026
