## Pledge Summary

Phillipsburg is a town of approximately 14,000 located in Warren County, NJ. Once a major transportation hub, it is a concentrated urban setting surrounded by agricultural land that is seeing a dramatic uptick in development. Phillipsburg Mayor Todd Tersigni has committed to saving the monarch butterfly & other pollinators by signing the Mayors' Monarch Pledge and looks forward to engaging residents in creating more pollinator habitat throughout the town.

## Action Items Committed for 2023

### Communications and Convening

- Issue a proclamation to raise awareness about the decline of the monarch butterfly and the species' need for habitat. This proclamation must incorporate a focus on monarch conservation.
- Launch or maintain a public communication effort to encourage residents to plant monarch gardens at their homes or in their neighborhoods. (If you have community members who speak a language other than English, we encourage you to also communicate in that language; Champion Pledges must communicate in that language.)
- Engage with city parks and recreation, public works, sustainability, and other relevant staff to identify opportunities to revise and maintain mowing programs and milkweed / native nectar plant planting programs.
- Engage with developers, planners, landscape architects, and other community leaders and organizers engaged in planning processes to identify opportunities to create monarch habitat.
