Pledge Summary

The City of Missouri City is a suburb of 75,000 residents in the Greater Houston Metro Area. Through our robust Parks and Recreation programs and community partnerships, we have achieved certification as a Platinum Scenic City in the state of Texas. Mayor Robin Elackatt's signing of the Mayors Monarch Pledge makes official the city's existing commitment to saving the monarch butterfly and other pollinators. We also are stepping up our efforts by partnering with the WIDE School here in Missouri City, which has established a Monarch Butterfly Waystation. Together, we will continue to educate and encourage residents to plant more milkweed and other plants native to this region of Texas, as well as building more pollinator habitats throughout our City.

Action Items Committed for 2023

Communications and Convening
