Pledge Summary

The City of Berwyn boasts a population of roughly 58,000 and is located west of Chicago. Originally a swampland, Berwyn is now known as the “City of Homes” and has two park districts, including a butterfly garden. The city also has one of the state’s largest Hispanic communities and recognizes the cultural significance that the monarchs hold for Mexican and Mexican American residents. The City of Berwyn is committed to promoting sustainable practices and initiatives that establish a foundation of conservation efforts for monarch butterflies.
