Pledge Summary

The Village of Sagaponack is historically an agricultural/residential community located on the eastern end of the south fork of Long Island in the state of New York. Our year round population is approximately 450 residents which doubles in the summer with the influx of second home owners. The Mayor, whose background is in farming, encourages, at each monthly meeting of the Board of Trustees, homeowners to consider planting their properties to encourage pollinators and to discourage harmful spray and pesticides. As a farming community it is important to balance the production of vegetables and the support of that ecological system.
