With 4,000 acres of open space and wildlife habitat preserved in perpetuity, including prairies, wetlands, and woodlands, the Town of Dunn makes an effort to be pollinator friendly.

Action Items Committed for 2025

Communications and Convening

- Issue a proclamation to raise awareness about the decline of the monarch butterfly and the species' need for habitat. This proclamation must incorporate a focus on monarch conservation.
- Launch or maintain a public communication effort to encourage residents to plant monarch gardens at their homes or in their neighborhoods.
